Nadra Ahmed CBE, DL Chairman – National Care Association

Nadra has been involved in the field of Social Care for over 40 years. She has been the Chairman of NCA since 2001 and is a trustee of Royal British Legion Industries and Governor at Canterbury Christchurch University. She is also the Co-Convenor of the Cavendish Coalition. She is currently the Chair of the Care Provider Alliance which brings together 11 national representative bodies in the sector.

Nadra has been a member of a number of Government advisory committees in the DHSC including at Ministerial level and Government Taskforces.
