| 1 | Entry Criteria | Entrants must be in education and/or employment with training, at one of the KFE college organisations (EKC Group, MidKent College and North Kent College (including Hadlow College), and/or have completed or be undertaking a relevant Level 2 or 3 or above programme within the last 12 months. | |
| 2 | Entrant Numbers | Standard entrant number per college organisation is 2 students for most industry rounds where more than 2 college organisations are participating and 3 per organisation where only 2 colleges are participating. | <ul style="list-style-type: none"> ○ Each college organisation (not campus) may register 1 entry per category for acting, dance and musical theatre. Acting may be solo or a group performance, dance may be solo or an ensemble with a max of 14 dancers, and musical theatre may be solo or a duo performance by students. ○ Confirmed max number of students in total: For this category numbers may vary. <p>The overall competition comprises of three Performing Arts competitions: Acting, Dance and Singing (Musical Theatre) and will consist of a public performance judged by a panel of judges and watched by competitors and an audience. Each area will be judged separately.</p> <p>Entrants must be in education and/or employment with training, at one of the four KFE colleges, and/or have completed or be undertaking a relevant 3 programme within the last 12 months.</p> <p>At the time of entry the entrants must have been challenged at the level of the competition. This means that entry is only possible through a qualifying process at your local college and with the endorsement and verification of the lead staff from that college.</p> |

| 5 | Duration | This is the time that the actual competition activity will take. | <p>Tech time and familiarisation with the theatre and Performing Arts area as follows.</p> <p>This will be chance to run the performances in the theatre. It is essential that all competitors arrive at the host college venue promptly for general registration between 8:45-9:15am to avoid delays in set-up.</p> <p>Once registered, competitors should head to the performance area 30 minutes before time slot to allow time to make their way to the performance area / theatre (as applicable). | 6 | The Skills Competition Task Details | This section describes the skills competition task to be undertaken in detail. | <p>Live Competition Brief</p> <p>To compete, performances must be no longer than 4 minutes. In the spirit of competition, whilst the tutors may support work, all work should be encouraged to be the student's(s') work.</p> <p>The choice of material for each sub-industry category is to be decided by each college. The material must be suitable for a 16+ audience (common sense should be applied to the appropriateness of content).</p> <p>There will be competitions in the following areas:</p> <ul style="list-style-type: none"> ○ Level 3 Acting - Devised or scripted (maximum of fourteen students) ○ Level 3 Dance – Any style (maximum of twenty students) ○ Level 3 Singing (Musical Theatre) (solo or duo with backing track) <p>Please note entries from published plays, musicals as well as the student's(s') own devised work are all suitable for this competition. Any permissions or licences required to perform such content should be acquired and responsibility for this rests with the student's(s') home college. Performing rights and copyright should be given consideration as performances may be recorded and promoted on the KFE website and / or YouTube channel.</p> <p>To help judge the student's(s') creativity please avoid lifting work directly from dance repertory or copying theatre performances. Any such performances should not be registered as entries for KFE4Skills.</p> |
| 7 | Marking & Assessment Requirements | This section provides the marking and assessment approach. | <p>Each competition module will be assessed and marked independently of any other competition activity, using objective and judgement criteria or a combination of both during each task.</p> <p>For all objective criteria, the following measurement will be used:</p> |

| 8 | Judges & Marking | This competition benefits from college and external judges. | <p>The KFE competition will use marking guides best suited to the industry event. An example scoring sheet is below at appendix 1.</p> <p>The KFE competition will use marking guides based on the criteria above. Judges will be selected from the expert KFE staff drawn from each college. The panel will normally number 5 Judges (one provided by each college) and in some cases may include an external judge from the industry sector. Judges’ decisions are final in all instances, although scoring will be open and transparent.</p> | | | | | | |
