1	Entry Criteria	Entrants must be in education and/or employment with training, at one of the KFE college organisations (EKC Group, MidKent College and North Kent College (including Hadlow College), and/or have completed or be undertaking a relevant Level 2 or 3 or above programme within the last 12 months.	
2	Entrant Numbers	Standard entrant number per college organisation is 2 students for most industry rounds where more than 2 college organisations are participating and 3 per organisation where only 2 colleges are participating.	<ul style="list-style-type: none"> ○ Each college organisation (not campus) may register up to (2) students. ○ Confirmed max number of students in total: 6 <p>Entrants must be in education and/or employment with training, at one of the KFE colleges, and/or have completed or be undertaking a relevant Level 2 or 3 or above programme within the last 12 months.</p> <p>At the time of entry the entrants must have been challenged at the level of the competition. This means that entry is only possible through a qualifying process at your local college and with the endorsement and verification of the lead staff from that college.</p>
3	Competition Prep	This section describes preparation needed for this competition.	<p>Preparatory Brief</p> <p>Health and Social Care is a lifelong career with many pathways and possibilities. This competition is the ideal platform to enable participants to demonstrate an awareness of health & social care values and their ability to plan a quality, meaningful activity for a service user.</p> <p>Competitors are required to produce a resource to support the cognitive development of an adult service user (18yrs+) within a health and social care setting, the type of setting can be of the competitor's choice.</p>

			<p>Evidence of planning and design will be required on the day; this could be via a written rationale, an activity plan or implementation leaflet.</p> <p>Competitors will be expected to verbally communicate their ideas and rationale to the judges upon request as well as the suitability of their activity to their chosen setting and service user.</p>

The resource has to be made on the day and parts cannot be made prior to the event.</p> <p>Competitors are required to produce a resource to support the cognitive development of an adult service user (18yrs+) within a health and social care setting, the type of setting can be of the competitor's choice.</p> <p>Evidence of planning and design will be required on the day; this could be via a written rationale, an activity plan or implementation leaflet.</p> <p>Competitors will be expected to verbally communicate their ideas and rationale to the judges upon request as well as the suitability of their activity to their chosen setting and service user.</p>

Identify how the resource will be used, the details can be presented in any form, the competitors are encouraged to be creative. <p><u>Creation:</u></p> <ul style="list-style-type: none"> ○ Create the resource adhering to own planning within the 2.5 hour time slot allocated.

			<ul style="list-style-type: none"> ○ Demonstrate health & safety throughout practical implementation appropriate to age ranges specified. <p><u>Instructions for usage:</u></p> <ul style="list-style-type: none"> ○ Produce a leaflet/activity plan (How to use your resource). ○ Be prepared to explain all the planning to judges on the day. <p><u>Overall quality of resource:</u></p> <ul style="list-style-type: none"> ○ Age suitability of the finished resource; and adherence to original brief.
